### **Definitions**

For purposes of this Agreement "Software" is defined as the ClearTrigger, ClearTrigger Lite, ClearReplica, ClearManage or ClearWeb computer program for which a key has been provided and any updates or maintenance releases thereto. The terms "you", "your" or "user" are synonymous, and refer to someone who purchases a license for the Software from A Better Solution, Inc. or an ABS authorized reseller. A "registered user" is a user who registers his/her purchase with ABS or the authorized reseller.

### **License**

You are granted a non-transferable license to use the Software on a single Software Region for ClearTrigger, ClearTrigger Lite or ClearReplica. A Software Region constitutes a Region Name (Usually your company name):Policy Depot pair. You may operate any number of clients from a Software Region. The license(s) may be used to activate its associated software and may not be resold. All license keys are valid for current and future versions of the Software and cannot be transferred. Verify before license installation that the correct Region Name and Policy Depots are returned, as keys are not replaced, new keys must be purchased. If at any time ABS does issue replacement keys, the original keys may no longer be used.

You are granted a non-transferable license to serve the Software from a single web-server for ClearWeb. A ClearWeb license is served from a single agreed upon machine host id. You may operate any number of web clients from this web-server. The License(s) may be used to activate its associated software and may not be resold. All License keys are valid for current and futures versions of the Software and cannot be transferred. Verify before license installation that the correct host id for the web-server is returned, as keys are not replaced, new keys must be purchased. If at any time ABS does issue replacement keys, the original keys may no longer be used.

### **License and Maintenance Fees**

Your purchase price included the first years License and Maintenance Fees (L&M Fee) of \$250.00/ClearTrigger License and/or \$250/ClearReplica License and/or \$150/ClearWeb License (US\$), and/or \$150/ClearTrigger Lite License (US\$), there is no annual L&M Fee for ClearManage. **Restrictions**

You agree that you will not give, rent, loan, resell or distribute a copy of the license to any other entity.
